Dear Friends,

Thank you for your interest in Angora Lakes Resort. We are currently booked for the 2026 season (mid-June to mid-September). We do expect some cancellations to occur and will keep your name on the waiting list for 2026 when you mail back the form below. If you do not hear from us and are interested in future summers, **please renew** your request in January of each year. We are still trying to accommodate people who have been waiting several years. We regret that we cannot fill the demand for cabin rentals but we sincerely welcome you as day visitors.

Resort facilities include a swimming beach, rowboat and kayak rentals and a snack shop. We have 9 small rustic housekeeping cabins, which hold a maximum of 4 to 6 people, depending on the cabin size. Rates vary between \$2100 to \$2700 per week, plus 14% county room tax. Cabins are **only rented by the week** (Sat-Sat or Sun-Sun, no splitting the week with others). The cabins have electric appliances (no microwaves or dishwashers), wood burning stoves for heat, showers, and ultra-low flow toilets. Smoking is not permitted in the cabins or on the decks. Guests bring their own towels as well as food. We have one ABA accessible cabin so please indicate if that is a necessity for you. We offer **no TV, landline phone, or internet service** and pets are not allowed. In keeping with the surroundings, we encourage guests to leave your electronics at home, and keep cell phones turned off.
